By making a "planned gift" — a gift through your estate — to Gift of Life Howie's House, you will help to ensure that we can maintain our affordable fees and broad array of services for all who need us, both now and in the future.

# You can ensure our future with a gift that costs nothing now.

Since opening our doors in 2011, Gift of Life Howie's House has provided over 85,000 nights of affordable lodging, 306,000 home-cooked meals, free transportation and other supportive services to over transplant families. Each night, House guests sleep well knowing that their needs are being met as their loved one goes through the process of qualifying for, receiving, and recovering from an organ transplant.

To help lighten the financial and emotional burdens of transplant care on families, the nightly rate at Gift of Life Howie's House is only \$40 per room, each room housing up to four people. This modest fee includes lodging, meals, transportation, and many other services. However, our actual cost to provide these services is over \$180 per night. To bridge this gap, we depend on ongoing charitable support from those who care about our mission, so that no family is turned away due to their inability to pay.

By making a "planned gift" — a gift through your estate — you can ensure the future success of Gift of Life Howie's House and have the satisfaction of knowing that your values will live on.

# Making a planned gift is easy.

Planned gifts can take many forms including cash, stocks, bonds, or other property. People who make charitable gifts through their estate plans may find that they are able to commit to larger gifts than they thought possible. And there are often tax advantages that benefit the donor, the estate and the beneficiaries.

### Four easy steps to making a planned gift

Planned gifts can take many forms including cash, stocks, bonds, or other property. Consider these steps:

**1.** Bequests – Name us as a beneficiary when you write your will or, if you already have a will, add a codicil amending it to include us.

Bequests can be a percentage of the remainder of your estate or a specific dollar amount. You can also make your bequest contingent upon the death of your spouse or another beneficiary.

Sample language for making a bequest:

"I give, devise, and bequeath to Gift of Life Howie's House, a non-profit 501(c)(3) charitable organization located at 401 Callowhill Street, Philadelphia, Pennsylvania 19123, EIN 26-0585694, or its successor-in-interest, [insert dollar amount or percentage] for its unrestricted use and purposes."

**2. Charitable Gift Annuities (CGA)** – In return for your irrevocable gift to us of cash or stock, we agree to pay you an annuity (a fixed rate of return) over your lifetime. Annuity rates are based on the age of the person receiving the annuity.

You may be entitled to receive a tax deduction for your gift the year it is made, and there may be other tax benefits if your gift included appreciated assets. Annuity payments may be partially tax free.

**3. Life Insurance Policies** – Name us as a beneficiary to a new or existing life insurance policy by completing a beneficiary designation form provided by your insurer.

**4. IRAs and other Qualified Retirement Plans** – Designate us to receive all or part of your IRA or other qualified retirement plan.

### Enjoy recognition during your lifetime as a Gift of Life Howie's House Legacy Society Member.

Donors who notify us that they have made planned gifts will be recognized — during their lifetimes — as members of our prestigious Gift of Life Howie's House Legacy Society. Members will be recognized in the quarterly newsletter and on our website, and will be invited to our yearly President's Appreciation Breakfast.

While gifts of all amounts are appreciated, donors who have made planned gifts of \$10,000 or more will also be recognized on our Legacy Society Wall located in the House.
